# **Stakeholder Process**

- Stakeholder process:
  - 1. Draft Approved Vendor requirements released Oct 3, 2018
  - 2. Stakeholder meeting and webinar held on Oct 10, 2018
  - 3. Stakeholder comments due on Oct 19, 2018
  - 4. Final Approved Vendor registration requirements posted on 10/31/2018
- Full list of all Approved Vendor requirements and the Program Administrator's evaluation criteria can be found on the Illinois ABP website
- Approved Vendor registration opened 11/1/2018 at 8 AM CT
- Highlights of changes from draft requirements
  - 1. Only representative marketing material for each channel needs to be uploaded with initial application
  - 2. Company financials are only required if requested by the Program Administrator
  - 3. Clarification of associated entities for disclosure purposes


